1. Exams

Every student is entitled to two examination opportunities per subject/semester. Students are automatically registered for both opportunities of exams (no extra subscription or payment is necessary).

EXAMS PERIOD:

Autumn term: 15 – 27 Jan. 2024 Spring term: 10 – 22 Jun. 2024

SPECIAL EXAMS PERIOD:

Autumn term: 5 – 17 Feb. 2024 Spring term: 1 – 13 Jul. 2024

UCO will send a Transcript of Records (ToR) non later than 5 weeks after the assessment period have finished by institutional Email to the corresponding international coordinator of the incoming exchange student.

2. Grading system of the institutions

University of Cordova: Student performance is graded individually and not on a statistical basis.

The grading scale ranges from 0 to 10 (5 or higher is a passing grade)

International students are not required to present a specific language certificate and do not need to pass a specific language level test.

Free Language courses:

International students with knowledge of B2 Spanish or less are encouraged to participate in the intensive courses before starting their studies in Córdoba (1). The courses are free of charge and offered to attend as any other subject (under academic quality) along each term in UCO. The organized/venue is UCOidiomas (University of Córdoba's Language center). Student has three levels according with their initial level (A1 to B2)

H. Insurance

Exchange students must present adequate medical coverage for their stay in Spain, in accordance with current regulations of their place of residence and / or the Spanish Consulate or Embassy where they apply for their visa.

In addition, it is compulsory to have travel and accident insurance before arrival at the University of Córdoba. Incoming students can obtain the same insurance coverage that the University of Córdoba offers its own students, which is private but has a special price (approximately EUR 19). More information at:

Other travel and accident insurance with equivalent coverage may also be accepted and must equally be presented.

It is also highly recommended for all EU citizens to obtain the European Health Insurance Card (EHIC blue card) before their arrival.

J. Admission Process

- 1. Institution must send a nomination/presentation letter with student data: full name, passport, studies and term(s) of exchange by the Institutional Coordinator.
- 2. Student must register on the online Application Form and send a copy of the report with the proposal of Learning Agreement to: incoming.student@uco.es.

To obtain the list of subjects, please click at a particular degree and then go to "Planificación de la enseñanza" and "Estructura general del plan de estudios".

(Note: It's **mandatory** to choose subjects from "1^{er}cuatrimestre" for autumn term (from September to February) or 2^ocuatrimestre for spring term (from February to July).

- 3. The proposal of Learning Agreement must be checked and accepted by the Coordinator of the School/Faculty where the student will be attending lessons in UCO.
- 4. Those students who intend to do internships in the area of Medicine / Nursing / Physiotherapy / Education must provide, additionally, Certificate of Criminal / Sexual Offenses in their Country.

Once in our country, they will be guided for the delivery of a certificate of confidentiality in the Office of International Relations and assistance to our Government Sub branch to be issued to them that have no history of such crimes in our country.

5. Once the Learning Agreement has been approved the student will received by email the admission letter electronically signed.

The student must keep all documents regarding the admission process if they are required by the international relations office.
